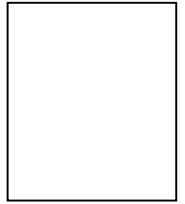

Standard terms and conditions:

5. The standard delivery period of services is 2 weeks from the date of acceptance of CRF by Netrut Digital Marketing Pvt. Ltd. The same however is subject to the mutually agreed delivery lead times during CRF acceptance stage.
6. If bills are unpaid for more than 15 days, services shall be deactivated.
7. Service numbers provided to your company by us can be used only for your own company's promotion as mentioned in the documents. This number cannot be used in promotion of any other company.
8. All future services (Toll-free, IVR, Missed Call) will be covered under this agreement.
